i. 19/00648/ALB / Woodland Cottage Main Street Maids Moreton Buckinghamshire MK18 1QU / Extension of existing chimney stack to ensure a flu height of 1.8m above the ridge of the thatch.

Members **RESOLVED** to Support 19/00658/APP & 19/00659/ALB for the following reasons;

The current roof is leaking and hence threatens the fabric of this listed building. The proposal is to re-roof with matching tiles and ridging and is supported by Heritage & Conservation.

iii. 19/00627/APP / 2 Duck Lake Close Maids Moreton Buckinghamshire MK18 1FB / Proposed first floor extension over existing garage, Two storey extension to rear of garage, single storey side extension and loft conversion to include rear dormer and front roof lights

 $After some \ discussion \ the \ members \ \textbf{RESOLVED} \ to \ Oppose \ 19/00627/APP \ for \ the \ following \ reasons;$

This property is already an overbearing intrusion in close proximity to Main Street and the Conservation Area. The proposed extension to both height and footprint is totally inappropriate. It would block out the already limited natural light for properties to the north east, as well as being highly visually intrusive on the Conservation Area. The proposed extension to the footprint would bring the whole property to within 1 metre of the plot boundary, where there is 1.5m rise in the ground level. Maids Moreton Parish Council request AVDC to reject the proposal.
